#### Counsel,

You are obligated to update the Supreme Court when you learn new material about the case. Further, you are obligated not to make false statements or present false evidence, including witness testimonies.

You and your witnesses made multiple false statements in the proceedings before the district and appeals courts. They claimed that the Big Platforms you represent have policies

- a) Against Holocaust denial and justification.
- b) To support medically proven treatment for COVID-19 and against medical misinformation, with an example of bleach or similar solution (MMS) for internal use.

Evidence shows that both claims are false.

A) One of the Google YouTube top executives responsible for content policy is a Hitlerite. In one of her tweets in 2017, she publicly praised Hitler and called the Holocaust a "great success". She was hired by Google/YouTube after that, not later than in 2021, despite (or because) management's knowledge of this.

Another high-level Google executive with content policy responsibility used to write that Jews have an "insatiable appetite for war and killing". Google might not have known about that when it hired him, but it did not part with him even when this fact became public and caused a scandal, which Google knew.

This contradicts your claims and YouTube witness statements on this subject.

**B)** Google/YouTube policy was blocking Ivermectin and Hydroxychloroquine, two safe and inexpensive drugs, highly efficient in COVID-19 treatment. Google occasionally promoted bleach or MMS.

This contradicts your claims and Google/YouTube witness statements on this subject. This conduct also constitutes a grave crime; those who aid Google/YouTube in its commission are punishable as accomplices.

# Holocaust Approval and Extreme Antisemitism



Notice that Ms. Retter also pushes an alternative history. Hitler built extermination camps, not walls. Hitler breached countries' borders, breaking walls and other defensive structures.

Kamau Bobb, Google's global lead for diversity

Kamau Bobb was Google's global diversity strategy and research Lead from 2018 to 2021.<sup>4</sup> In 2021, after his comments caused a scandal, he was reassigned to the position of Director of the STEM Education Strategy.<sup>5</sup>

Kamau Bobb wrote in 2007: "If I were a Jew I would be concerned about my insatiable appetite for war and killing...". Then his career took off. Kamau Bobb was a White House Office of Science and Technology Policy member in 2014-2017. Google likely hired him because of his political views.

Other Nazi Sympathies

Google/YouTube turned toward Nazism after their preferred candidate lost the 2016 elections. Here are some notes for you:

#### Medical Misinformation on COVID-19

### Blocking Ivermectin and Hydroxychloroguine

Contrary to the claims by NetChoice, Google/YouTube blocked information about effective medicines for COVID-19, such as Ivermectin and Hydroxychloroquine. Its policy document (archived on September 17, 2021; did not substantially change until early 2023, at least) stated:

"Don't post content on YouTube if it includes any of the following: Treatment misinformation:

- ..
- Content that recommends use of Ivermectin or Hydroxychloroquine for the treatment of COVID-19
- Claims that Hydroxychloroquine is an effective treatment for COVID-19
- Categorical claims that Ivermectin is an effective treatment for COVID-19
- Claims that Ivermectin and Hydroxychloroquine are safe to use in the treatment COVID-19

Read this page attentively.

Ivermectin became the medicine of choice for COVID-19 treatment in the fall of 2020, but most doctors treating COVID-19 patients at the beginning of the pandemic successfully used Hydroxychloroquine.<sup>7</sup> Google/YouTube and other Big Platforms politicized and effectively blocked this treatment.

YouTube continues banning truthful but inconvenient information about the dangers of COVID-19 vaccines (e.g., prohibited "Claims that contradict health authority and World Health Organization guidance on safety, efficacy and ingredients of currently administered and approved vaccines.")<sup>8</sup>

This should not be so surprising, given the adoration of Hitler, justification of genocide, and collective responsibility of racial, ethnic, or religious groups for real or imagined grievances at the upper levels of Google/YouTube.


